


LEWIS, ALD. COX, ALD. KING AND ALD. PACK IN ATTENDANCE

1. Mayor Burdette called the meeting to order and gave the invocation.
2. Minutes of the Jan. 11, 1982, regular meeting were read and approved.
3. Mayor's Comments: (a) Mayor Burdette reminded the Council of the meeting with Consolidated Foods on Thursday afternoon, Jan. 28, 1982.
4. Aldermen's Comments: (a) Ald. Lewis commended Harold Kirby and Dean Harris on the outstanding job of the Street Dept. in removing the snow and ice from the streets during the recent storm.
5. Public Comments: (a) Ald. King made a motion to bring the amusement license request of Bobby Parker before the Council, 2nd by Ald. Lewis with Ald. Pack and Ald. Cox voting affirmatively also.
 - (b) Ald. King made a motion to deny the Bobby Parker license request, 2nd by Ald. Lewis with Ald. Cox and Ald. Pack voting affirmatively also.
 - (c) Dennis Bradley made a request for a taxi license for two cabs. He stated he was obtaining insurance with Greeson's Insurance. Ald. Pack made a motion to approve the license, 2nd by Ald. Cox with Ald. Lewis and Ald. King voting affirmatively also.
 - (d) Mayor Burdette appointed Ald. Lewis and Ald. King to work with the City Clerk in reviewing and redrafting the business license ordinance.
6. Old Business: (a) A fourth reading was given to the Emergency Management Ordinance. Ald. Pack made a motion to table until Feb. 8, 1982, 2nd by Ald. Cox and approved.
 - (b) A second reading was given to the following annexation ordinance requests for R-1 zoning. They are as follows:
 - (1) George and Margaret Lee house and lot adjoining Rayford Hall off Peters Street (ordinance number 4 - ordinance book)
 - (2) Emil Moore, Jr., house and lot on Belmont, Burton Drive, adjoining property of Frances Burton (ordinance number 2 - ordinance book)
 - (3) Mrs. E.E. Moore, Sr., house and lot fronting on Belmont Dr. and adjoining property of Emil Moore, Jr. (ordinance number 3 - ordinance book)
 - (4) Ruth French house and lot in Black Oaks Subdivision off Belmont Dr. (ordinance no. 1)
 - (5) Robert & Ruby Dorsey renter house and lot off Dan Cheri Dr. bounded on back by city limit property (ordinance no. 5 - ordinance book)
 Ald. Cox made a motion to approve, 2nd by Ald. King with Ald. Pack and Ald. Lewis voting affirmatively also.
 - (c) John Sweitzer of Sweitzer and Peoples gave the Council a review of the water expansion project and gave a report on the financial position of the project.
 - (d) Mark Stendal of Hensley-Schmidth Engineers stated that any funding for step 2 of the EPA 201 project was not likely for Calhoun and his firm would present plans of work to be done in steps on the local level over the next two or three years. These will be ready to present in approximately two months.
 - (e) Ald. Lewis made a motion to authorize Mayor Burdette to sign the water/sewer grant amendment, 2nd by Ald. Cox with Ald. King and Ald. Pack voting affirmatively also. (project number 80-WS/WPC-10 - Industrial Park)
 - (f) City Supt. Hobgood reported that both 100 HP motors for the Sewer Plant had been received and are in operation. A new gear box is to come in shortly. He reviewed the streets in the City and found a minimum amount of damage due to the snow and ice. Repairs will be made.
7. New Business: (a) Ald. Pack made a motion to grant a 15 ft. variance off Valley Circle for the erection of a terminal box for Southern Bell, 3½ ft. high, on the right-of-way. 2nd by Ald. Cox with Ald. Lewis and Ald. King voting affirmatively.
