

1. Mayor Burdette called the meeting to order and Rev. Walter Perry gave the invocation.
2. Minutes of the Feb. 8, 1982, regular city council meeting were read and approved.
3. Mayor's Comments: (a) The Clerk was congratulated on being elected president of the Georgia Municipal Clerks and Finance Officers Asso.
- (b) Chief Grizzle reported that Fireman Lenning's condition would be better as soon as his treatments were regulated.
4. Aldermen's Comments: Alderman Lewis made a motion to adopt a resolution expressing the city council's appreciation for the assistance extended to the City by the County Commissioners, particularly Commissioner W. P. Hunt, in the procurement of the final stretch of right-of-way for the connecting road from Red Bud to Dews Pond to Highway 53. 2nd by Ald. Cox with Ald. Pack, Ald. King and Mayor Burdette voting affirmatively also.
5. Public Comments: (a) A request for a trailer permit for Rickey Ray off Talley Avenue was presented. After discussion, Ald. Pack made a motion to grant a six months temporary permit, the motion did not receive a second.
- (b) Ald. Pack made a motion to return the Kenneth Harrison amusement license request to the floor, 2nd by Ald. Cox with Ald. Lewis and Ald. King voting affirmatively also.
- (c) Ald. Pack made a motion to approve the license for/ the former Reese's building on the New Town Road off the Red Bud Road, since the police report was approved, 2nd by Ald. Lewis with Ald. Cox and Ald. King voting affirmatively also.
6. Old Business: (a) The second reading was given to the following annexation ordinance requests, Ald. Lewis made a motion to approve as read, 2nd by Ald. Cox with Ald. King and Ald. Pack voting affirmatively also:
1. Kenneth Ingle, lots 121 and 122 of the Morningside addition to Calhoun bound by Creekview for R-2 zoning (Ordinance no. 8 - ordinance book)
  2. Joseph & Mary Ann Hammond, two tracts off Dews Pond Road, bound by Tommy Curtis and Luther Roberts for R-1 zoning (ordinance no. 9 - ordinance book)
  3. The Raymond King Company, Inc., lot on Highway 53, bound by West May Street, 200' x 200' for C-2 zoning (ordinance no. 10 - ordinance book)
- (b) City Supt. Hobgood reported:
1. Street Dept. has been concentrating on drainage problems - continue to work in the Spring Valley area
  2. County is assisting the City with fill work on the old landfill area on Sugar Valley Road to convert to practice fields for the Recreation Dept.
  3. City water crews have placed approximately one mile of 6" line in the Hill City area.
  4. Romines contractor has been working on Highway 156 West.
  5. Raw water intake work has been hampered due to high river.
  6. City did purchase the last stretch of right-of-way for the connector road extending from Highway 156, Dews Pond to Highway 53.
  7. Ald. Cox made a motion to authorize the City Superintendent to sign L & N Railroad permits for water/sewer bores for the City of Calhoun. 2nd by Ald. King with Ald. Lewis and Ald. Pack voting affirmatively also.
- (c) Mark Stendal of Hensley-Schmidt Engineers reported on the current status of the water/sewer EDA, EPA grants for the Industrial Park. Ald. Pack made a motion to accept the amended engineer's contract to include the extra work and authorize the Mayor to sign when approved by Attorney Tom Shanahan. 2nd by Ald. Cox with Ald. Lewis and Ald. King voting affirmatively also.
- (d) Mark Stendal reported that the proposed Waste Treatment Plant improvements

would be approximately \$480,000.00 to be locally funded over the next two years. More details will be presented on March 8, 1982.

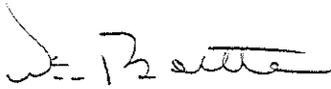
7. New Business: (a) A first reading was given to the following annexation ordinance requests:

1. Wilborn Johnson, lot 37 and the south 1/3 of lot 35 of the Spring Valley Subdivision and being bound by Stewart Drive for R-1 zoning
2. Ronnie and Jean Jackson, a 200' x 200' house & lot at the intersection of Burton & Belmont Drive for R-1 zoning

(b) Ald. King made a motion to adopt a resolution amending the City's 1981-82 budgets to reflect a net increase in income and expenses by \$410,864.00 as per the attached, 2nd by Ald. Lewis with Ald. Pack and Ald. Cox voting affirmatively also.

8. Ald. Pack made a motion to adjourn, 2nd by Ald. Cox with Ald. Lewis and Ald. King voting affirmatively also.
