

1. Mayor Burdette called the meeting to order and gave the invocation.
2. Minutes of the Jan. 25, 1982, meeting were read and approved as amended.
3. Mayor's Comments: (a) Mayor Burdette reminded the Council of the meeting with Gordon County Tuesday, Feb. 9, 1982, at 7:30 p.m. in the city courtroom.
- (b) Fire Chief Grizzle stated that Fireman Dick Lenning seemed to be doing well for the surgery he had undergone.
4. Aldermen's Comments: None
5. Public Comments: (a) Ald. Lewis made a motion to approve a taxi license for Howard Talley subject to the insurance requirements, 2nd by Ald. Cox with Ald. King and Ald. Pack voting affirmatively also.
6. Old Business: (a) Ald. King made a motion to reconsider the Emergency Management Ordinance, 2nd by Ald. Pack with Ald. Cox and Ald. Lewis voting affirmatively.
- (b) A fifth reading was given to the Emergency Management Ordinance. Ald. King made a motion to approve, 2nd by Ald. Pack with Ald. Lewis and Ald. Cox voting affirmatively also. (Ordinance no. 6 - in ordinance book)
- (c) City Supt. Hobgood reported that he had received his new car. He had attended a water resource management seminar which was informative. The Street Dept. has begun work on street damage. He met with Supt. Moreland of DOT last Thursday requesting State assistance. Of the 19 streets listed on the LARP list 11 of these were accepted. Supt. Hobgood added South Industrial Blvd. and North Industrial Blvd. to the list and hopes for some help with them. Electric Dept. has completed the work at Gordon County Farms. He reported that the County per Eddie Peterson had agreed to use Albea Construction for the airport work. He had notified the engineers to contact Albea. The water projects have very little progress due to the weather. The Sewer Plant has received a gear box from Passavant and that the earliest date to receive another box would probably be August. He is contact the purchasing agent to order another box for a delivery date of no earlier than July, 1982.
- (d) A second reading was given to the A. W. Richards annexation request for his his house and frontage property off West Belmont Dr. for R-2 zoning. Ald. Lewis made a motion to approve, 2nd by Ald. Pack with Ald. King and Ald. Cox voting affirmatively also. (Ordinance no. 7 in ordinance book)
7. New Business: (a) A first reading was given for the following annexation ordinance requests:
1. Kenneth Ingle - lots 121, 122 of the Morningside addition to Calhoun bound by Creekview for R-2 zoning
  2. Joseph and Mary Ann Hammond, two tracts off Dews Pond Road, bound by Tommy Curtis and Luther Roberts for R-1 zoning
  3. The Raymond King Company, Inc., lot on Highway 53, bound by West May Street, 200' x 200', for C-2 zoning
- (b) Ald. Lewis made a motion to approve a resolution authorizing condemnation of Bowman Transportation, Inc. property for a sewer easement, 2nd by Ald. King with Ald. Cox and Ald. Pack voting affirmatively.
