


- AAG461
1. Mayor Burdette called the meeting to order and gave the invocation.
 2. Minutes of the March 22, 1982, regular meeting were read and approved.
 3. Mayor's Comments: (a) Ald. Lewis made a motion to name W. C. Burdette as the voting delegate at the GMA convention, 2nd by Ald. King with Ald. Pack and Ald. Cox voting affirmatively also.
(b) Ald. Lewis made a motion to nominate Mayor W. C. Burdette for the Mottie Wiggins award and authorized the City Clerk to prepare the nomination, 2nd by Ald. King with Ald. Pack and Ald. Cox voting affirmatively also.
(c) Mayor Burdette stated that he and the Council were very impressed by the construction to date on the water extension and raw water intake project. He stated that all those departments, contractors and engineers associated with the project are to be commended.
 4. Aldermen's Comments: (a) Ald. Cox commended Water Plant Supt. Estes Pass and his workers for their prompt action in the recent chemical spill.
 5. Public Comments: (a) Ald. Lewis made a motion to approve an amusement license for two video game machines for Johnny Harkins, Murphy's (no police report necessary due to recent report regarding beer license), 2nd by Ald. Pack with Ald. King and Ald. Cox voting affirmatively also.
(b) A request to hire off duty police officers by Murphy's was referred to the local licensed security agencies.
 6. Old Business: (a) A second reading was given to the ordinance regarding adoption of a parade route for the city.
(b) A first reading was given to an ordinance dealing with solicitations by organizations within the city.
(c) A second reading was given to the Don Lewis de-annexation request for approximately 5 acres off Frontage Road on the east side of the city.
(d) City Supt. Jim Hobgood reported:
 1. After discussing the sweeper bids, and after negotiations with the companies, he announced plans to purchase a model 600 air sweeper demonstrator at a price of \$55,000.00 with the Council's approval.
 2. Street work complete on the Beamer Road and work is now underway on South River Street.
 3. Water/Sewer Const. Dept. made 22 water taps and 4 sewer taps in March. City crews have finished their work in Hill City and have moved to the Forster-Lusk Road beyond Tucker Hollow. Supt. Hobgood said the water line crew had done an excellent job on all the city lines installed by city crews with only one leak developing out of several miles of line.
 - (e) Ald. Cox made a motion to declare the three former Sutherland houses on River Street surplus property and auctioned off on May 15, 1982, and removed from the property to allow street construction, 2nd by Ald. King with Ald. Pack and Ald. Lewis voting affirmatively.
 7. New Business: (a) The City Clerk gave a report on the bidding results for the city's group medical insurance. The Council asked the Clerk to obtain specific coverage cost per items and have group meetings with employees regarding dependent coverage and report back to the Council later in the month.
(b) Ald. Cox made motion to approve the City/Department of Transportation Airport construction agreement and to authorize the Mayor to sign all matters pertaining thereto, 2nd by Ald. Pack with Ald. King and Ald. Lewis voting affirmatively also.

- (c) A first reading was given to the application of a beer license for Billy Sanders for the American Legion Post 555. A public hearing was set for April 26, 1982.
- (d) Ald. Pack made a motion to approve a six foot variance for Acey Cronan on Windsor Drive in order for a garage to be erected, and due to the fact that the adjoining neighbor, Preece, acknowledged the encroachment and had no objection. The motion was second by Ald. Lewis with Ald. Cox and Ald. King voting affirmatively also.
- (e) Ald. Pack made a motion that due to Capt. Dick Lenning's eighteen and one-half years of service with the City that he be granted an additional two months wages based on 50% of normal salary. 2nd by Ald. King with Ald. Cox voting affirmatively. Ald. Lewis stated that he was very much in sympathy with Capt. Lenning and his situation, but he felt the City had a very liberal sick leave policy and that it was sufficient without exceptions.
8. Ald. Pack made a motion to adjourn, 2nd by Ald. Lewis with Ald. Cox and Ald. King voting affirmatively also.
